

**CRITERIA FOR  
DAYTON AREA BOARD OF REALTORS®  
2017 OWNER/MANAGER-OF-THE-YEAR**

**Purpose** – The purpose of the “Owner/Manager of the Year” program is to give special recognition to an owner or manager of the Dayton Area Board of REALTORS® who has rendered outstanding service to the real estate industry.

An applicant must be a member in good standing with the Dayton Area Board of REALTORS® for at least 8 years. An applicant who has been found guilty of violating the Code of Ethics or the Ohio Revised Code during the past 8 years is ineligible.

**QUALIFICATIONS** – An applicant is evaluated on the following participation criteria:

- a. DABR Committees and/or special assignments from 2010 through 2017.
- b. OAR Committees and/or special assignments from 2010 through 2017.
- c. NAR Committees and/or special assignments from 2010 through 2017.
- d. Educational achievements such as professional designations.
- e. Community and civic activities, religious organizations, service clubs, charitable and volunteer groups from 2010-2017.

The president of the Board, the president-elect, the immediate past president and the current members of the Recognition Committee shall not be eligible for nomination as Owner/Manager - of-the-Year.

Owners and managers shall not be eligible for nomination as REALTOR®-of-the-Year.

The Owner/Manager award may only be received once. Past recipients of this award are ineligible.
