An applicant who has been found guilty of violating the Code of Ethics or the Ohio Revised Code during the past 8 years is ineligible. An application must be a participant in the current Sales Leader Award program.

QUALIFICATIONS – An applicant is evaluated on the following participation criteria:

- a. DABR Committees and/or special assignments from 2011 through 2017.
- b. OAR Committees and/or special assignments from 2011 through 2017.
- c. NAR Committees and/or special assignments from 2011 through 2017.
- d. Educational achievements such as professional designations.
- e. Community and civic activities, religious organizations, service clubs, charitable and volunteer groups from 2010-2017.

The president of the Board, the president-elect, the immediate past president and the current members of the Recognition Committee shall not be eligible for nomination as REALTOR-of-the-Year.

Owners and managers shall not be eligible for nomination as REALTOR®-of-the-Year.

The REALTOR of the Year award may only be received once. Past recipients of this award are ineligible.
