

**CRITERIA FOR
DAYTON REALTORS®
2018 OWNER/MANAGER OF THE YEAR**

Purpose – The purpose of the “Owner/Manager of the Year” program is to give special recognition to an owner or manager of the Dayton REALTORS® who has rendered outstanding service to the real estate industry.

An applicant must be a member in good standing with the Dayton REALTORS® for at least 8 years. An applicant who has been found guilty of violating the Code of Ethics or the Ohio Revised Code during the past 8 years is ineligible.

QUALIFICATIONS – An applicant is evaluated on the following participation criteria:

- a. Dayton REALTORS® Committees and/or special assignments from 2011 through 2018.
- b. Ohio REALTORS® Committees and/or special assignments from 2011 through 2018.
- c. NAR Committees and/or special assignments from 2011 through 2018.
- d. Educational achievements such as professional designations.
- e. Community and civic activities, religious organizations, service clubs, charitable and volunteer groups from 2011-2018.

The Dayton REALTORS® president, president-elect, immediate past president and the current members of the Recognition Committee shall not be eligible for nomination as Owner/Manager - of-the-Year.

Owners and managers shall not be eligible for nomination as REALTOR® of the Year.

The Owner/Manager award may only be received once. Past recipients of this award are ineligible.
