

**2022 REALTOR® GOOD NEIGHBOR
AWARD NOMINATION FORM**

The purpose of the REALTOR® Good Neighbor Award is to recognize a REALTOR® who has provided outstanding community service contributions in our community or to Dayton REALTORS® sponsored programs.

The criteria to be considered in the selection process are:

1. Eligible individuals include all active REALTOR® members.
2. Active involvement in Civic, Service, Community organizations or Dayton REALTORS® board sponsored programs. A nominee should be actively involved in the organization to the extent the nominee's participation has made significant contributions to the community.

Examples of Dayton REALTORS® sponsored programs include: Toys for Tots, Habitat for Humanity, Rebuilding Together Dayton, Dayton REALTORS Golf Outing, Dayton REALTORS Committees, Dayton REALTORS Officers and Directors.

Selection Process:

1. Nominations may be made by self-submission, another REALTOR® member, or the Dayton REALTORS® Recognition Committee.
2. Nominee or individual with personal knowledge of nominee's participation fills out and returns the nomination form. Nomination forms may be submitted via email, US Post Office mail or in person.
3. The Recognition Committee will review the nominees and select recipient.
4. If there are no nominees there will be no award presented. If the Recognition Committee does not feel any of the nominees are worthy of consideration, the award will not be given.
5. All nomination forms must be received in the Dayton REALTORS® office by 5:00 p.m., Nov. 1, 2022. Fax submissions will be accepted.

6. All nomination forms must include a digital photo. The photo must be a head and shoulders photo only with no props. Digital photo size must be at least 300x400 pixels at 200 dpi. The photo should be emailed to kpitchel@daytonrealtors.org.

7. Contact information for the community service organization is required.

8. Award presented to recipient at the 2023 Installation Event.
