

**CRITERIA FOR  
DAYTON REALTORS®  
2023 OWNER/MANAGER OF THE YEAR**

**Purpose** – The purpose of the “Owner/Manager of the Year” program is to give special recognition to an owner or manager of Dayton REALTORS® who has rendered outstanding service to the real estate industry.

An applicant must be a member in good standing with Dayton REALTORS® for at least 8 years. An applicant who has been found guilty of violating the Code of Ethics or the Ohio Revised Code during the past 8 years is ineligible.

**QUALIFICATIONS** – An applicant is evaluated on the following participation criteria:

- a. Dayton REALTORS® Committees, accomplishments and/or special assignments from 2016 through 2023.
- b. Ohio REALTORS® Committees and/or special assignments from 2016 through 2023.
- c. NAR Committees and/or special assignments from 2016 through 2023.
- d. Attendance at Ohio REALTORS Conference from 2016 through 2023.
- e. Educational achievements such as professional designations.
- f. Community and civic activities, religious organizations, service clubs, charitable and volunteer groups from 2016-2023.

The president of the Board, the president-elect, the immediate past president and the current members of the Recognition Committee shall not be eligible for nomination as Owner/Manager of the Year.

Sales agents shall not be eligible for nomination as Owner/Manager-of-the-Year.

The Owner/Manager of the Year award may only be received once. Past recipients of this award are ineligible.
